


St Kitts was so highly thought of by the French and British that they fought over it for 200 years, becoming in the process one of the richest islands in the Caribbean thanks to its sugar industry and access to European markets. Now there is an investment opportunity opening up in St Kitts that promises not just a hefty return on capital, but citizenship and passports for any investor of good repute and their family.

Under a deal negotiated between Range Developments, a Dubai-based development company, and the Government of St Kitts and Nevis, anyone investing in the Park Hyatt St Kitts will qualify for a full Commonwealth passport, assuming they meet strict qualifying requirements.

The passport arrangement will also apply to the investor's spouse and eligible dependents, who will then be entitled to visa-free travel to 139 countries around the world, including Canada, the United Kingdom, and many European Union member states.

Range Developments is particularly targeting high net worth individuals across the globe that have passports from countries where internal strife or domestic tax and security regimes have added to the complexities of life.

The project is to build a 5-star beach resort at Banana Bay on the south side of St Kitts, to be operated by the Park Hyatt hotel group.

"An investment in our real estate project entitles the buyer to a share in a 5 star branded hotel that will deliver an annual income yield from the outset and deliver all the benefits associated with Citizenship of St. Kitts & Nevis to investors of good character," said Mohammed Asaria, Vice Chairman of Range Developments.

The development has a cap of 400 individual investors to fund the project, with limited inventory remaining available.
